Ancient Algeria has known many empires and dynasties, including ancient Numidians, Phoenicians, Carthaginians, Romans, Vandals, Byzantines, Umayyads, Abbasids, Idrisid, Aghlabid, Rustamid, Fatimids, Zirid, Hammadids, Almoravids, Almohads, Ottomans and the French colonial empire. Berbers are generally considered to be the indigenous inhabitants of Algeria. Algeria is a regional and middle power.
