President Macron succeeded in this negotiating coup, as leader, (young) of this Europe at 27, alongside Chancellor Angela, Merkel, like his predecessor, Nicolas Sarkozy, who also obtained an agreement in 2008, after the subprime crisis. They took away supplies from states to return it to Europe and redistribute it to Member States. it is a very strong upheaval, and very rapid, because the urgency of the COIVD-19 crisis, the recessional impact of which is alarming.

The unprecedented and historic aspect of this agreement at 750 billion euros, falls under

this new character, because it is the first time that the European Union has proved to be able to share debt in the name of solidarity.

This is how Europe has shown, and honors its sovereign and the very foundations of its "spirit of solidarity", and therefore of a common indebtedness, and for the first time, a mutualisation of the debts of the member states.

It is a concrete translation of budgetary solidarity and European debts, after laborious negotiations, with "egoistic" approaches from the start before reaching the unanimous agreement. The questions about the repayments of this colossal loan to be repaid in 2058 ... and how the expenses will be allocated, with all this money.

Create jobs in the industrial summer ecological sector (the hydrogen electric battery) and in training for young people to be re-converted, will be financed by Europe "and we are committed to finding new clean sources by raising international taxes on those partners who do not pay their contributions ". explained President Macron.

The CAP (Common Agricultural Policy) , this food sovereignty, our negotiations have made it possible to guarantee the income of our farmers for the next 7 years. We fought and maintained this budget. It is also the access for the departments of the regions and in particular the regions overseas. It is also the access for the digital sectors and we are the 3rd country to benefit from this money from Europe, without having to finance it either by our taxes or by our own loans, and we are going to receive €40 billion. » acknowledged President Macron.-----

We will discuss and there is no right of veto, on governance, on a member state. There will always be sovereignty of the Member State, there will be support for financing between culture, health, education, new industrial and ecological sectors. "

"It is not the French taxpayer who will pay for this agreement, because we will be able to levy a European tax on international players who do not play the game" "Of the 40 billion euros that we will receive will not be taken from our own resources , but on European loans, and the digital taxes of those actors who do not pay tax until now, digital and also on plastic "The Carbon mechanisms at the borders during the import of the end steel from the world to avoid an unfair conference, such as from India or elsewhere, this tax prochain is innovative and will allow this debt to be financed by this new European tax system and this will allow us to apply our ecological objectives "said French President Macron , on the occasion of his interview by journalist Julien Arnaud on the TV channel Tf1.
