"It is intolerable because, by the extent of damage and disorders they have generated, they threaten the republican order.

Intolerable also because they involve unacceptably independence and serenity with which court decisions must be made."

In the penitentiary center of Attention, disorders took place. The prosecutor went on the scene and the Regional Response Teams and security (ERIS) intervened. Calm has returned in the district prison and fire starts were circumscribed.

I want to remind everyone that solemnly, in a democracy, Justice's decisions are not contestable by the Law pathways. The Court of Appeal shall have to state the right and I intend it to do so independently.-----

Finally, I address my support for the victims of the riots and my gratitude to the security forces mobilised to contain them." [?] Christiane Taubira, french Minister of Justice said.
