I strongly condemn all attacks on civilians, especially where chemical weapons are used." Jean Marc Ayrault said.

ALEPPO REBEL -HELD WAS THE TARGET OF A CHEMICAL ATTACK YESTERDAY AUGUST 10-----

French Foreign Affairs Minister Jean Marc Ayrault has condemned this chemical attack. A district of Aleppo rebel-held yesterday was the target of a chemical attack, according to medical sources and a group of civil protection. Hamza Khatib, who heads the Al-Quds hospital in Aleppo, told a Reuters photographer that the hospital had identified four dead by gas poisoning and 55 wounded, seven of which were still receiving hospital care.-----

Syrian Civil Protection, a group of lifeguards present in areas held by the rebels, said he found three dead and 22 injured after a barrel containing what appears to be chlorine descended on the neighborhood Zoubdiya. The group added will not be able to independently verify the nature of the gas. France is concerned about reports of a new chemical attacks that have occurred in the city of Aleppo on August 10, which would have cost the lives of four people and left dozens injured. I strongly condemn all attacks on civilians, especially where chemical weapons are used. The Organization for the Prohibition of Chemical Weapons (OPCW) has had occasion to confirm, in the past, attacks with chlorine gas against the Syrian population from helicopters only the forces of the Syrian regime have in flagrant violation of international law. "I shall be particularly attentive to the findings of the UN investigation and the OPCW to be established at the end of August on proven cases of chemical attacks in 2014 and 2015. The tragedy of the Syrian people for over five years and despicable attacks he suffered were the result of the cynical attitude of the regime and its supporters in Syria that prevent any political solution. With nearly 300 000 deaths, this ordeal has lasted too long. France calls for a cessation, immediate, hostilities, which alone will make possible the resumption without delay of negotiations in the true spirit of responsibility."
